About us

Wavecare has been providing mental health and wellbeing support to people living in or connected to the City of Monash for over 40 years, helping those in need of assistance due to illness, grief & loss, abuse, anxiety, depression, trauma, homelessness, crisis, misfortune, disability, relationship issues and isolation.

The skilled practitioners at Wavecare Counselling Services have professional qualifications and training, and several years of experience in providing clinical and therapeutic interventions appropriate to meet the needs of our diverse clients. Some of our specialist interventions include Cognitive Behavioural Therapy, Family and Systems Therapy, Acceptance and Commitment Therapy, Mindfulness Based Cognitive Behavioural Therapy, Play Therapy and Dialectical Behaviour Therapy.

As a not-for-profit community-based organisation, we work with clients across their entire life-span, offering inclusive care to people from diverse cultural and linguistic backgrounds, as well as people who identify as LGBTQI+.

Our service offerings have expanded as we have grown, demonstrating our ability to respond to identified community needs. We now offer information and education sessions to various interest groups on a variety of topics affecting their lives, and offer social connectedness for our elderly community members who live at home through our popular Glencare Program. We are always on the lookout for areas where we can support our community better.

C.E.O Report

"Mindfulness is relaxing, calming and helpful to clear your mind."

When Australia went into lockdown for 43 days in March 2020 it was inconceivable that it would continue until October 2021. All up, Victorians spent 254 days in lockdown and the consequence on people's mental health has been substantial and universal.

The Australian Bureau of Statistics' National Study of Mental Health and Wellbeing' found that during the height of the pandemic, 21.4% of Australians experienced a mental health disorder, the most common was anxiety.

The statistics also show that more than two in five Australians aged 16-85 experience a mental health issue in their lifetime. In 2020-21, 3.4 million Australians sought help from a health care professional for their mental health.

More and more people are taking their mental wellbeing seriously. They are seeking help through GPs, psychologists and online tools. The growth at Wavecare has reflected this: we have gone from 4 to 9 psychologists, 50% increase in appointments offered since 2018; increase in our socialisation group from one day to 2 days.

Our programs are committed to offering everyday tools to help our Monash population manage their mental health and reduce stress, anxiety and depression - to stay connected with other people, be physically active, learn a new skill, to volunteer, help others and practice mindfulness.

This year, we have held free mindfulness sessions, in both English and Mandarin, and they have been well attended and received by the community. We will continue this in our work program next year. We are thankful to Pinewood Community Banking for providing funding for this programme.

The demand on Wavecare Services this year has grown significantly. We continue to actively support

and advocate for the continuation of the Federal Government's Medicare commitment of 20 funded sessions each year, which makes our services accessible to the community.

Our professional, committed and amazing counsellors and psychologists have enabled Wavecare to continue to deliver excellent services. Thank you for your ongoing commitment: Suzy Adler, Pari Balsara-Mistry, Catherine Gooden, Hiromi Karahwara, Dianna Mackay, Ray Paterson, Yvonne Schroder, Sue Troupakis, Tania Wallace and Poly Chen-Han Yang.

Our Glencare program continues to grow, and we welcomed Chris Miles into the role of Activities Co-ordinator. We are now running our social inclusion group twice a week and it's wonderful to witness the camaraderie, laughter, and music. Thank you to Pari and Chris for running an inclusive and fun program and thank you to all the volunteers who have continued to make such a great contribution to Glencare.

Over the past year we have continued supervising students in their Masters of Social Work program - they have worked with our clients, the Glencare program and overall management of Wavecare. Thank you to Ray Paterson for managing this program.

The Board continue to donate their time and services each month, and they are a guiding and integral part of Wavecare, and to me. Their support and expertise is much appreciated. Thank you to Denis Carruthers, John McKenzie, Swami Nathan, Lesley Potucek, Lalitha Rajan, Sunitha Raman and Paul Ng. A huge thank you to Trudy and Georgia for ensuring that Wavecare runs smoothly each and every day. Finally, thank you to Monash City Council for backing Wavecare and their ongoing support in the vital work to the community we are proud to do.

"We pivoted our approach and tried to implement our program in an innovative manner while we were in lock down."

"Pivot and hybrid..." probably two of the most dominant words used in the work force during the pandemic; and certainly something Glencare has had to do in response to numerous lock downs. The last financial year was still a struggle as Victorians saw themselves in and out of a few more lock downs that significantly affected individuals, especially our ageing population. Those living on their own found themselves considerably isolated with minimal contact from family, friends or community groups while others opted for a more cautious approach and refrained from leaving their homes.

To uphold the very essence of Glencare – which is social connectedness, we pivoted our approach and tried to implement our program in an innovative manner while we were in lock down. All Glencare service users were contacted regularly via phone and zoom meetings were conducted weekly with volunteers and participants who had access to technology. We also organised a music performance via zoom which was well received and thoroughly enjoyed by all. Games, puzzles and art materials were personally delivered to people's houses which motivated them to be creative albeit on their own.

As our 6th and final lockdown eased, Glencare was finally able to resume activities from the hall which was a welcome change to our service users, volunteers and staff. Glencare operated with high levels of safety, upholding the standards of care outlined by the government.

The pandemic may have brought with it several challenges, but that propelled us to enhance service delivery and reach out to the community even more. Michelle and I took the opportunity to apply for additional funding to run Glencare on a second day, only to be delighted by the application being approved within a few weeks. I can proudly say that Glencare operates successfully twice a week since November 2021.

Last October, we bid farewell to Maggie Benko who retired after many years of working at Wavecare. Maggie was part of our administration team and eventually, I lured her into Glencare! She passionately engaged with all the participants and planned some of the most fun craft activities Glencare has ever witnessed. A big thank you to Maggie for her time, support and dedication to the program. As we bid Maggie farewell, we welcomed the very dynamic Chris Miles into the program. Chris started as a volunteer and has now taken over the role of activities co-ordinator.

Sadly, one of our Glencare participants, Felicia Cincini (Gina), passed away this year. She started at Glencare as a volunteer and then joined the group as one of the participants. Gina enjoyed her time at the program and will be missed by all.

While other support programs have shut down during the pandemic, Glencare continues to run successfully and one of the key reasons, is my supportive and dedicated team of volunteers. Thank you Joop Van de Guard, Ian Bjorkman, Anjula Kumar, Des Butler and Dianne White. Your commitment to the program is truly commendable. I am fortunate to be supported by the most wonderful colleagues and board members at Wavecare and I would like to thank all of you for being my source of inspiration.

Finally, I would like to offer my sincerest gratitude to the City of Monash for giving us a space to run Glencare.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared to satisfy the Financial reporting requirements of the Associations Incorporation Reform Act 2012. The Board of Directors has determined that Wavecare is not a reporting entity. The financial report has been prepared on an accrual basis.

NOTE 2: GOODS & SERVCES TAX

Wavecare is registered for GST.

NOTE 3: PUBLIC BENEVOLENT INSTITUTION

Wavecare is registered as a Public Benevolent Institution and receives GST Concessions and also FBT and Income Tax Exemptions.

NOTE 4: RENT IN KIND

City of Monash support to Wavecare includes provision of operational and office space valued at \$7,178 p.a. for Glencare and \$20,000 p.a. for general administration and counselling space. This has been included as grant income and expensed as Glencare & Administration expenditure.

Independent Review Report

To the Members of Wavecare Inc:
